

TERMS & CONDITIONS

RESERVATION AND PAYMENT

A NON-REFUNDABLE DEPOSIT OF \$2500.00 PER PERSON WILL BE REQUIRED AT THE TIME OF BOOKING. TO ENSURE YOUR RESERVATION, THE FINAL PAYMENT WILL BE DUE 90 DAYS PRIOR TO THE TOUR'S START. BOOKINGS MADE WITHIN 90 DAYS PRECEDING THE TOUR'S START WILL REQUIRE FULL AND FINAL PAYMENT IMMEDIATELY UPON BOOKING. IT IS THE RESPONSIBILITY OF THE TRAVELER (OR AGENT) TO DETERMINE THAT THE FINAL PAYMENT REACHES US ON TIME. NO BOOKING WILL BE CONSIDERED UNTIL THE FINAL DEPOSIT IS RECEIVED BY THE TOUR OPERATOR. PAYMENTS ARE TO BE MADE VIA BANK TRANSFER OR CREDIT CARD. ANY FEES CHARGED, WILL BE THE RESPONSIBILITY OF THE SENDER. PLEASE INQUIRE ABOUT THIS BEFORE YOU MAKE YOUR PAYMENT.

CANCELLATIONS AND REFUNDS

DUE TO HIGH PREPARATION COSTS, CANCELLATIONS MUST BE RECEIVED IN WRITING WITHIN 90 DAYS OF THE TRAVEL DATE. CANCELLATIONS RECEIVED 90 DAYS PRIOR TO TOUR START DATE WILL BE SUBJECT TO A FULL REFUND OF TOTAL AMOUNT PAID (MINUS THE \$2500.00 NON-REFUNDABLE DEPOSIT) DEPENDENT UPON THE RESERVATION TO BE FILLED BY ANOTHER TRAVELER. CANCELLATIONS RECEIVED AFTER 90 DAYS OF THE TOUR START DATE WILL RECEIVE NO REFUND. NO REFUND WILL BE MADE FOR TRANSFERS, CITY TOURS, OR ANY OTHER SERVICES (INCLUDING MEALS, ACCOMMODATIONS, OR TRANSPORTATION) VOLUNTARILY NOT TAKEN. IF FOR ANY REASON TRAVEL IS NOT PERMITTED OR INTERNATIONAL BORDERS ARE CLOSED, THE TOUR WILL BE POSTPONED TO A LATER DATE.

CHANGES

ITINERARY IS SUBJECT TO CHANGES IN ORDER TO ADAPT TO POSSIBLE ALTERATIONS IN DOMESTIC FLIGHT TIMES OR OTHER UNFORESEEN CIRCUMSTANCES. THE CONTENT WILL REMAIN THE SAME, BARRING ANY UNANTICIPATED COMPLICATIONS, AND WILL INCLUDE MANY DELIGHTFUL "EXTRAS" AND SURPRISES. HOTELS WILL BE THE SAME AS LISTED IN THE ITINERARY. IN THE EVENT OF A HOTEL CHANGE, PLEASE BE ASSURED THAT THE ALTERNATIVE WILL BE TO THE SAME STANDARD OR HIGHER.

INSURANCE

WE RECOMMEND THAT ALL PARTICIPANTS OBTAIN TRAVEL INSURANCE FROM A REPUTABLE COMPANY THAT COVERS INTERNATIONAL TRAVEL AND ALL REASONABLE UNFORESEEN EVENTS WHICH COULD IMPACT YOUR TRIP. FOR EXAMPLE, TRAVEL INSURANCE SHOULD COVER AT LEAST THE FOLLOWING BUT NOT LIMITED TO COVERAGE FOR MISSED CONNECTIONS DUE TO WEATHER; LOST DEPOSITS DUE TO THE FINANCIAL DEFAULT OF THE AIRLINE, THE TOUR OPERATOR, OR CRUISE LINE; BAGGAGE DELAYS, TRAVEL DELAYS, MEDICAL EXPENSES, AND EMERGENCY ASSISTANCE.

WAIVER OF RESPONSIBILITY

BY SIGNING UP FOR THE TOUR (SENDING YOUR DEPOSIT) YOU AGREE TO OUR TERMS, CONDITIONS, AND WAIVER. WE HAVE WORKED DILIGENTLY TO MAKE THE ARRANGEMENTS FOR OUR JOURNEY TOGETHER. HOWEVER, WE WILL NOT BE HELD LIABLE FOR DELAYS, THEFT, DAMAGE, INJURY, OR ANY OTHER IRREGULARITIES THAT MAY OCCUR DURING THE JOURNEY. WE WILL NOT BE HELD LIABLE FOR ANY CHANGES OR DELAYS IN AIRLINE SCHEDULES OR MISSED CONNECTIONS; INJURY, LOSS, OR DAMAGE TO PERSONS OR PROPERTY; ADDITIONAL EXPENSES RESULTING FROM CHANGES IN EXCHANGE RATES, TARIFFS, OR ITINERARY; ANY TRANSPORTATION ISSUES OR PROBLEMS WITH VEHICLES UTILIZED ON THE TOUR; ADDITIONAL EXPENSES INCURRED DUE TO ILLNESS, WEATHER CONDITIONS, PROTESTS, WAR, TERRORISM, QUARANTINE, OR OTHER CAUSES; AND LOSSES DUE TO CANCELLATIONS NOT SUBJECT TO OUR TERMS AND CONDITIONS.
